

## Trusts

### How it works

Before Govett Quilliam can act for you, by law<sup>1</sup>, we have to properly identify and collect information about its clients. We collect this in three steps.

### 1. Verification of Trust

We will need to review a copy of the Trust Deed (and any variations or deeds of retirement and/or appointment).

### 2. Verification of Trustees' and Beneficial Owners' ID and Address

We will verify the identity and address of all the trustees (unless the Trust is registered with the Charities Commission or similar) and, if not also a trustee, the beneficial owners of the Trust (the person(s) with the power to appoint or remove trustees).

For **individual trustees**, at least one form of identification must contain a photo. Please choose from one of the following options:

(Note: Options 2 and 3 require one primary and one secondary document)

<b>Option A</b>	<ul style="list-style-type: none"> <li>• Bank statements or correspondence</li> <li>• Government agency statement</li> <li>• Registered KiwiSaver or superannuation scheme correspondence</li> <li>• IRD correspondence</li> <li>• Current insurance policy</li> </ul>	<p>These documents should be no more than 12 months old. They must show your current residential address. We cannot accept digital versions.</p>
<b>Option B</b>	<ul style="list-style-type: none"> <li>• Local authority rates or water bill</li> <li>• Utility bill (gas, power, fixed phone line, internet, SKY TV)</li> <li>• Signed tenancy or lease agreement</li> <li>• Correspondence from a New Zealand educational institution (e.g. primary schools, secondary schools, tertiary institutions, that report under the Ministry of Education in NZ)</li> </ul>	<p>These documents should be no more than 3 months old. Digital copies of utility statements and insurance policy are acceptable, provided the statements show you are taking responsibility for a fixed (non-moveable) service or fixed asset at the same address the statement would otherwise have been posted to. A tenancy or lease agreement must be signed by both the tenant(s) and landlord.</p>

For **corporate trustees**, we will verify the identification of each trustee in accordance with the process for verifying private companies (see below).

## 3. Verification of Source of Wealth/Funds

We are also required to verify the source of wealth/funds, for which the following information will be required:

## 4. Other Information

If your identification documents are issued by a country other than New Zealand, Australia, The United Kingdom, Canada, France, Germany or the United States of America, we may need to ask you for additional information about your income or assets.

Documents must be originals. We can also accept copies certified by a trusted referee. Please contact us for further information .

Documentation in a foreign language must be accompanied by an independent and certified English translation provided to you by a professional translator.
